The Artemis Diamantouros Memorial Award will be presented to a student registered in Year 2, 3 or 4 of the PharmD program at the Leslie Dan Faculty of Pharmacy who demonstrates outstanding leadership contributions to the pharmacy profession and inspires others to do the same.

The recipient must have achieved a minimum academic standing of Second Class Honours (if enrolled in Year 2 or 3) or at least a Pass standing in all courses (if enrolled in Year 4). The recipient must also be eligible for financial assistance.

Candidates may be self-nominated or may be nominated by faculty or staff of the Leslie Dan Faculty of Pharmacy. No student may receive the award more than once. The award will not be given if a suitable candidate is not identified.
